Together in the fight against common diseases RAYDIAX and the Research Campus STIMULATE institutionalize long-term partnership

Securing future patient care through the minimally invasive treatment of common diseases: This is the goal that the Research Campus STIMULATE and RAYDIAX GmbH have set themselves. Around 200 people have been working on technical solutions to achieve this goal within the research campus since 2012, mainly at the Magdeburg site. RAYDIAX GmbH, a spin-off founded in 2022 by former scientists from Otto von Guericke University/the Research Campus STIMULATE, is developing a specialized image assistance system for this type of particularly patient-friendly surgery. The aim of the therapy assistance computer tomograph is to enable significantly more patients to receive minimally invasive treatment in future and to enable more clinical staff to perform these operations.

In future, RAYDIAX GmbH and the Research Campus STIMULATE research campus will work even more closely together. RAYDIAX joined the STIMULATE-Verein e.V. in December 2023, deepening the partnership both clinically and technically. The aim of both partners is to work together in future on innovative issues relating to minimally invasive therapies, particularly in the area of therapy assistance.

The company was founded in 2022 and is headquartered at the Research Campus STIMULATE in Magdeburg's Port of Science. The science spin-off is a spin-off of scientists from Otto von Guericke University Magdeburg. The foundation of the company was based on a 3-year EXIST research transfer grant from the Federal Ministry of Economics and Climate Protection (BMWK), which was approved in 2021. The focus of technical development is on both hardware and software for computer tomographs.
